RUDE, ARROGANT, AND UNRULY BEHAVIOR IS A GROUND FOR DENIAL OF VISA APPLICATION. 粗鲁, 倨傲以及不守规矩的行为将直接导致拒签。 4. VISA IS NOT A RIGHT BUT A PRIVILEGE EXTENDED. 获得签证不是申请人应得的权利, 而是领事馆赋予的特权。 5. A VALID VISA DOES NOT NECESSARILY GUARANTEE ENTRY TO THE PHILIPPINES. THE IMMIGRATION OFFICER AT THE PORT-OF-ENTRY WILL CONDUCT AN INSPECTION TO DETERMINE IF THE INDIVIDUAL IS ELIGIBLE FOR ADMISSION UNDER PHILIPPINE IMMIGRATION LAW. 一张有效的签证并不能保证持有人得以入境菲律宾。因为菲律宾入境口岸的移民局官员将根据菲移民法对签证持有人进行审查以决定是否允许其入境菲律宾。
