**RESOLUTION RECOMMENDING THE PROCUREMENT OF GLASS DIVIDER

OFFICE AREA IN THE CONSULAR SECTION OF XIAMEN PCG**

**WHEREAS**, the Philippine Consulate General in Xiamen (Xiamen PCG) has endeavored to procure one (1) lot of glass divider to be installed between the receiving counter and the back office area in the Consular Section of Xiamen PCG through **GPPB Resolution No. 28-2017, "Approving the Guidelines for the Procurement of Goods and Services, Infrastructure Projects and Consulting Services to be Procured and performed Overseas;**

**WHEREAS**, there is a need to procure the glass divider to replace the shattered glass divider between the receiving counter and the back office area in the Consular Section of the Consulate General;

**WHEREAS**, Xiamen PCG, through its Bids and Awards Committee (BAC), solicited Request for Quotations (RFQ) from three (3) selected providers;

**WHEREAS**, only Xiamen Youke Construction Engineering Co., Ltd. has responded to the Request for Quotations and provided its quotation for the procurement of various office supplies;

**WHEREAS**, upon evaluation of the BAC, the quotation provided by Xiamen Youke Construction Engineering Co., Ltd. is within the prescribed Abstract of Canvass (ABC) at **RMB3,486.21** which is favorable to Xiamen PCG;

**WHEREAS**, said company is capable of providing the requested glass divider;

**NOW THEREFORE**, for and in consideration of the foregoing, WE, the members of the Bids and Awards Committee (BAC) of Xiamen PCG, hereby resolve and recommend to the Head of Post and Head of Procuring Entity (HOPE) to award the contract through GPPB Resolution No. 28-2017 to **Xiamen Youke Construction Engineering Co., Ltd.**;




