OF REPLACEMENT OF WORN-OUT BRAKE COMPONENTS FOR XIAMEN PCG'S  
SERVICE VEHICLE (14-SEATER VAN)**

**WHEREAS**, the Philippine Consulate General in Xiamen (Xiamen PCG) needs to urgently attend to the needed repair of the worn-out brake components for Xiamen PCG's service vehicle (14-seater van), plate No. 19202, Property No. 2013-06-01-0002-0080 through **GPPB Resolution No. 28-2017, "Approving the Guidelines for the Procurement of Goods and Services, Infrastructure Projects and Consulting Services to be Procured and performed Overseas;**

**WHEREAS**, the brake components of Xiamen PCG's service vehicle (14-seater van) are worn-out due to wear and tear;

**WHEREAS**, Xiamen PCG needs to procure the supply and installation of replacement brake components for its service vehicle (14-seater van) to ensure the road worthiness of the said vehicle and guarantee the safety of its users especially during official trips to far cities within Post's jurisdictions;

**WHEREAS**, Xiamen PCG, through its Bids and Awards Committee (BAC), solicited Request for Quotations (RFQ) from three (3) service providers;

**WHEREAS**, only Xiamen Baogutong Vehicle Service Co., Ltd. has responded to the Request for Quotations and provided its quotation for the required service needed by Xiamen PCG;

**WHEREAS**, upon evaluation of the BAC, the quotation provided by Xiamen Baogutong Vehicle Service Co., Ltd. is within the approved budget at **RMB800.00** which is favorable to Xiamen PCG;

**WHEREAS**, said company is capable of providing said services;

**NOW THEREFORE**, for and in consideration of the foregoing, WE, the members of the Bids and Awards Committee (BAC) of Xiamen PCG, hereby resolve and recommend to the Head of Post and Head of Procuring Entity (HOPE) to award the contract through GPPB Resolution No. 28-2017 to **Xiamen Baogutong Vehicle Service Co., Ltd.**;






