**RESOLUTION RECOMMENDING PROCUREMENT OF COMPULSORY
TRANSPORTATION INSURANCE AND COMMERCIAL TRANSPORTATION
INSURANCE FOR XIAMEN PCG'S SERVICE VEHICLE MERCEDEZ BENZ E250**

WHEREAS, the Philippine Consulate General in Xiamen (Xiamen PCG) has endeavored to procure a compulsory transportation insurance and commercial transportation insurance for Xiamen PCG's service vehicle Mercedes Benz E250, Plate No. Min19206Ling, through **GPPB Resolution No. 28-2017, "Approving the Guidelines for the Procurement of Goods and Services, Infrastructure Projects and Consulting Services to be Procured and performed Overseas"**;

WHEREAS, the procurement of compulsory transportation insurance and commercial transportation insurance from a reputable establishment is necessary as the insurance for Xiamen PCG's service vehicle Mercedes Benz E250 will expire on 07 April 2026;

WHEREAS, Xiamen PCG, through its Bids and Awards Committee (BAC), solicited Request for Quotations (RFQ) from insurance providers;

WHEREAS, in response to the Request for Quotations, only Ping An China provided quotation for the insurance needed by Xiamen PCG;

WHEREAS, upon evaluation of the BAC, the quotation provided by **Ping An China** is within the prescribed budget at **RMB1,627.90**, which is favorable to Xiamen PCG;

WHEREAS, said company is capable of providing said insurance;

NOW THEREFORE, for and in consideration of the foregoing, WE, the members of the Bids and Awards Committee (BAC) of Xiamen PCG, hereby resolve and recommend to the Consul General and Head of Procuring Entity (HOPE) to award the contract through GPPB Resolution 28-2017 to **Ping An China**;

RESOLVED at the Philippine Consulate General in Xiamen, People's Republic of China this 20 March 2026.




